

# FUNDING APPEAL: URGENT SUPPORT NEEDED FOR PRIORITIZING THE MOST CRITICAL NEEDS ON CCCM & SNFI SECTOR ACROSS THE BAY STATES, NIGERIA

## CURRENT SITUATION

**1.9%** CCCM funding received

**4.6%** SNFI funding received

**920K** IDPs without adequate shelter

**Displacement in Northeast Nigeria continues to rise due to conflict, climatic shocks, and economic hardship, leaving millions without safe shelter or basic items for survival.** Despite escalating needs, the CCCM and Shelter/NFI sectors remain among the most underfunded in the 2025 Humanitarian Response Plan (HRP).

- **The HRP targeted 1.4 million people for CCCM with a funding requirement of \$16 million. To date, only 1.9% has been received.**
- For Shelter/NFI, 1.5 million people were targeted with a budget of \$55 million. Yet, less than 4.6% of the required funding has been secured.
- As a result, over 920,000 IDPs remain without adequate shelter, NFIs, or camp management support, facing heightened protection risks, disease exposure, and repeated displacement.

**Since January 2025, 55,580 people across 110 sites in Borno, Adamawa, and Yobe have been directly affected by fires, floods, windstorms, and evictions.** Flooding has led to collapsed shelters, destroyed NFIs, and forced spontaneous relocations, leaving families stranded in precarious conditions.

Reception centers, the entry points for screening, registration, and referrals, are on the verge of collapse. Of the 7 centers in Borno State, 3 (Monguno, Ngala, and Banki) are critically overstretched and at risk of shutting down without urgent support, which would severely compromise the reception and protection of new arrivals.

**The withdrawal of major donors has further reduced operational capacity. Many partners have already scaled down or exited, leaving vast areas uncovered and thousands of families without SNFI support.**

## CONSEQUENCES

- Families living in unsafe, overcrowded shelters are exposed to disease, weather extremes, and protection risks, particularly affecting women, children, and persons with disabilities.
- Essential NFIs should include mats, blankets, kitchen sets, mosquito nets, and clothing, many of which have been lost to flooding or remain unavailable due to depleted sector stocks.
- Site conditions are deteriorating rapidly, with eroded foundations, collapsed structures, and flooded communal areas, further hindering aid delivery.
- Continued partner withdrawal will leave entire LGAs uncovered, deepening humanitarian suffering and undermining stability.

## IMMEDIATE SECTORIAL HIGHLIGHTED NEEDS



### CAMP COORDINATION AND MANAGEMENT

There is an immediate need for CCCM services, including site facilitation and coordination, information management, and the dissemination of information. Site environment and infrastructure maintenance and improvements are also required, such as clearing local drainage channels and sandbagging in temporary settlements following these incidents. These services are urgently needed across all IDP sites situated in flood-risk areas.

CCCM responses are equally required for flood-affected populations now residing in overcrowded reception centres, host communities, or occupying public spaces such as schools. This includes DRR mitigation measures and ensuring that site management systematically incorporates preparedness for seasonal hazards. **The urgent funding requirement for the CCCM response is USD 1.25 million.**



### SHELTER

There is an urgent need for shelter construction and maintenance kits for 8,925 affected households, as well as alternative accommodations for IDPs living in flood plains. Essential materials in the maintenance kits should include timber, tarpaulins, and nails. **The urgent funding requirement for the shelter response is USD 1.4 million. Continued partner withdrawal will leave entire LGAs uncovered, further deepening humanitarian suffering and undermining stability.**



### NON-FOOD ITEMS

The majority of IDPs (7,954 households) require NFIs, particularly as many are sleeping in overcrowded spaces and makeshift shelters. Essential NFIs should include mosquito nets, kitchen sets, hygiene kits, bedding, and warm clothing. **The urgent funding requirement for the NFI response is USD 1.2 million.**

## CALL FOR ACTION

**Without immediate donor support, thousands of families will remain exposed to life-threatening conditions.** Your contribution will provide safe shelter, restore dignity, and ensure critical camp management services for the most vulnerable.

**By bridging this urgent funding gap, donors will prevent further displacement, reduce protection risks, and stabilize humanitarian access in one of the world's most fragile contexts.**
