






August Key Highlights:

- 230,309 individuals reached through Site Management activities in August 2025. Children represented 66% of beneficiaries, adults 32%, and elderly 2%.
- 231 participants (105 females and 126 males benefited from 15 capacitybuilding sessions conducted for site committees, local authorities, and partners.
- 31 site management committees established and capacitated across states.
- 7 functional Complaints and Feedback Mechanisms (CFMs) established.
- **426 cases** referred and tracked by site management partners.
- 10 awareness-raising campaigns conducted on governance, health, and cholera prevention.





- **3,448 Individuals** reached with site maintenance support.
- **226,178 Individuals** reached with site assessment activities.

Cumulatively, **749,776 individuals** have been reached by Site Management activities from January–August 2025, representing **39%** of the HRP target (**1.9M** Individual).

Progress Towards 2025 HNRP Strategic Objectives

Objective 1: Strengthen Access to Multi-Sectoral Services





Site assessments in August 2025 reached 226,178 individuals across Blue Nile (70,682), North Darfur (92,408), and Central Darfur (63,088). BMDO led registration and verification in Baw locality, Blue Nile, while NRC and UPO supported mapping and profiling in North Darfur camps, and DRC conducted assessments in Central Darfur.

- 3.448 individuals benefited from site maintenance support in Gedaref and Tawila, North Darfur, through
 - NRC referred 426 cases through established CFMs in Tawila camps, with 76 individuals receiving multisectoral assistance.




Objective 2: Enhance Community Resilience and Engagement

- NRC, ACTED, BMDO, and UPO supported the establishment and training of 31 site management committees across Gedaref, White Nile, Blue Nile, and North Darfur. Training sessions focused on governance, ToRs, referrals, and cholera preparedness.
- 15 capacity-building sessions were delivered by NRC, ACTED, DRC, and UPO, engaging over 231 committee members, local authorities, and partners.
- **NRC's** cholera sub-committees in Tawila organized awareness campaigns reaching over **426,000** Individuals with prevention and health messages.

Objective 3: Improve Site Protection and Accountability





- NRC and ACTED established 7 functional Complaints and Feedback Mechanisms in Tawila camps (North Darfur) and informal sites in Gedaref, ensuring two-way communication with displaced communities.
- NRC tracked 426 referrals through CFMs in Tawila camps, while ACTED supported community-led CFM processes in Gedaref and White Nile.
- ACTED and DRC engaged local communities in Gedaref, White Nile, and Central Darfur to strengthen
 participation and ensure inclusive representation in decision-making structures. UPO also delivered capacitybuilding for camp committees in North Darfur.

Challenges

- Access and administrative approvals continued to delay site management roll-out in Central Darfur (Golo and Nertiti).
- Heavy rains and flooding restricted site maintenance activities in Gedaref, while damaging infrastructure in several informal sites.
- Limited partner capacity constrained timely follow-up on the high number of referrals in Tawila camps.
- Partners reported critical funding gaps in Blue Nile and White Nile, threatening the continuity of site monitoring and committee support.
